Federal Government Policy Changes Impacting Saskatchewan's Growth Plan

On behalf of Technology Professionals Saskatchewan (TPS), I am writing to you to share our concerns about recent federal government policy changes that will limit Saskatchewan's ability to educate, train, and retain skilled engineering technology professionals. The Federal Government's policy changes will impact our province's economic competitiveness and the Saskatchewan Growth Plan goal of increasing the provincial population to 1.4 million by 2030.

TPS is the only regulatory body in the province for Professional Technologists, and Certified Technicians. TPS evaluates the academic and experiential qualifications of individuals who apply for registration / enrollment, and issues professional designations accordingly based on provincial requirements related to education, experience, and professionalism, in accordance with the "**Saskatchewan Applied Science Technologists and Technicians Act**" (**SASTT Act**).

Many Professional Technologists (PTech), and Certified Technicians (CTech) began their careers by coming to Saskatchewan as international students, to study in an engineering technology diploma program. These programs, many of them with integrated co-operative education work terms, provided them with the training needed to enter the work force in Saskatchewan, contributing much needed skilled labour in the manufacturing, construction, and mining sectors, to name only a few.

In October, Immigration, Refugees and Citizenship Canada (IRCC) updated its list of Classification of Instructional Programs (CIP) codes which are used to determine if an international student entering a program of study can obtain a post-graduate work permit (PGWP). Although these efforts were intended to prioritize international student enrolment in post-secondary programs that train graduates for careers that help fulfill the demand for skilled labour, critical college diploma programs in engineering technologies and other applied technologies were excluded from the eligible CIP code list.

This decision to exclude engineering technologies was in part prompted by the experiences of international students in central Canada who obtained technology diplomas but were unable to obtain related employment upon graduation. That is not the case in Saskatchewan, as international students graduating from technology programs consistently obtain employment in the career for which they trained, and often have their choice of opportunities. International students often fill critical labour shortages in smaller Saskatchewan cities, as they are willing to relocate and build careers in these communities. Saskatchewan employers on technology program advisory committees consistently report hiring both domestic and international program graduates and predict growing labour needs in their sectors.

TPS believes that with your leadership as Minister of Advanced Education in Saskatchewan, as well as the Minister Responsible for the "**SASTT Act**", we can help the Government of Canada correct this oversight and ensure that international students will have opportunity to enroll in Saskatchewan college programs that help meet provincial labour force demands.

TPS would appreciate the consideration of your Ministry in communicating the Federal Government's oversight in hopes that they may reconsider and reverse their decision. Further, we hope that your Ministry has the opportunity to communicate the critical role that engineering technology professionals play in the growth of a healthy Saskatchewan economy.

New Professional Designation for Technology Professionals Saskatchewan (TPS) Technologists


Since the mid 1980's, the Provincial Professional Associations (PPAs) that represent the applied science / engineering technology profession across Canada have used numerous designations to identify registered professional Technologists. Such designations include: ASCT, CET, PTech, RET, TScA, etc. Over the past number of decades, numerous attempts to reach a common designation for technologists have not been successful.

At the 2024 Annual Meeting of Technology Professionals Canada (TPC), all nine provincial member associations agreed to pursue "P.Tech." or "PTech" as the sole professional designation to be awarded to applied science / engineering Professional Technologists in Canada. Having one designation for Professional Technologists will increase recognition of professional qualifications on a national level, assist with unification of interprovincial mobility, and avoid confusion of the public.

Subsequently, at the 2024 Annual Meeting of TPS held in Saskatoon, the registered professionals unanimously agreed to change the Regulatory Bylaws thereby including the use of PTech or P.Tech. for registered Professional Technologists in Saskatchewan.

The Minister responsible for the "Saskatchewan Applied Science Technologists and Technicians Act", has now granted approval to amend the Regulatory Bylaws and allow for the use of PTech or P.Tech.

In October 2024, TPS issued a Professional Technologist Certificate of Registration to all members who were registered as Applied Science Technologists. Registered Professional Technologists should immediately cease and desist from using the ASCT designation and commence using PTech or P.Tech. following their name on business cards, email signatures, etc. within the Province of Saskatchewan.

THE TECHNOLOGY RING



The Technology Ring is a symbol of professionalism and is traditionally worn on the fifth finger of the working hand. It is the exclusive domain of registered professional applied science / engineering technologists and certified technicians in Canada. The ring is formed by a repeating pattern of five gears bracketed by a maple leaf on each side. The gears represent the five members of the engineering / design team: trades person, technicians, technologists, engineers, and scientists. The ring is available for purchase to TPS Professional Technologists (PTech), and Certified Technicians (CTech) only.

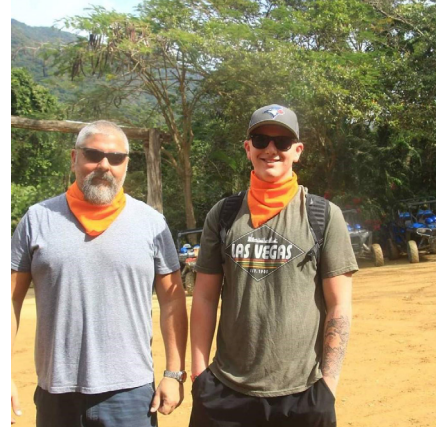

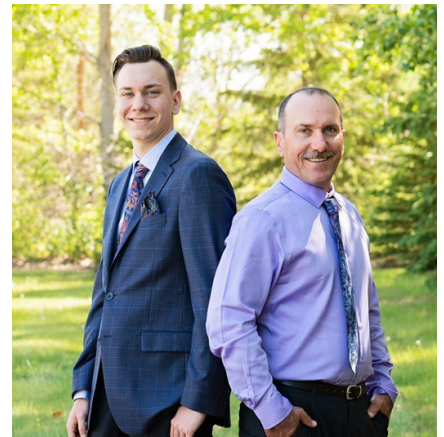
